**PART I. General Expectations**

Forest Hill Elementary agrees to implement the following statutory requirements:

- Consistent with section 1118, the school will work to ensure that the required campus Title I Parent Engagement Plan meet the requirements of section 1118(b) of the ESEA, and include as a component, a school-parent compact consistent with section 1118(d) of the ESEA.
- The school will notify parents of the plan in an understandable and uniform format and, to the extent practicable, in a language the parents can understand. The plan will be made available to the local community and updated annually to meet the changing needs of parents and the school.
- In carrying out the Title I, Part A parental engagement requirements, to the extent practicable, the school will provide full opportunities for the participation of parents with limited English proficiency, parents with disabilities, and parents of migratory children, including providing information and school reports required under section 1111 of the ESEA in an understandable and uniform format and, including alternative formats upon request and, to the extent practicable, in a language parents understand.
- If the school's Parent Engagement Plan for Title I, Part A, developed under section 1112 of the ESEA, is not satisfactory to the parents of participating children, the school will submit any parent comments with the plan when the school submits the plan to the district.
- The school will involve the parents of children served in Title I, Part A schools in decisions about how the one percent of Title I, Part A funds reserved for parental engagement is spent.
- The school will build its own and the parent's capacity for strong parental engagement, in order to ensure effective involvement of parents and to support a partnership among the schools, parents, and the community to improve student academic achievement.
- The school will provide other reasonable support for parental engagement activities under section 1118 of the ESEA as the parents may request.
- The district and the school will be governed by the following statutory definition of parental engagement and will carry out programs, activities and procedures in accordance with this definition:

**Parental engagement** means the participation of parents in meaningful two-way communication involving student academic learning and other school activities, including ensuring—

- A. that parents are informed of school values and expectations integral in supporting their children's education;
- B. the reciprocal understanding of schools and families that support meaningful parent-school partnerships;
- C. that parents are encouraged to be actively engaged in their child's education and school;

- D. that parents are equal partners in their child's education and are included, as appropriate, in decision-making and on advisory committees to assist in the education of their child; and
- E. the carrying out of other activities, such as those described in section 1118 of the ESEA.

**PART II.** Forest Hill Elementary will implement the required components of the campus Title I Parent Engagement Plan.

1. Forest Hill Elementary will take the following actions to involve parents in the joint development of its campus Parent Engagement Plan under section 1112 of the ESEA:

- Establish the campus Parent Engagement Advisory Council adequately represented by parents of attending children, administrators and Title I personnel. Other council members may include community members and students.
- Annually hold a meeting to review, discuss, and revise the school's Title I Parent Engagement Plan.
  - An open invitation will be sent out to parents by means of a letter in the student's take home folders. The invitation to participate in the revision of the Parent Engagement Plan will be distributed in the spring semester. Parents who provide feedback or show interest in participating will be invited to the meeting for revision of the plan. If there is insufficient response, a personal invitation via a phone call will be made to parents until full participation is achieved. This meeting will be offered in English and Spanish as well as other languages, if the need arise in order to accommodate all parents.

2. Forest Hill Elementary will take the following actions to involve parents in the process of school review and improvement under section 1116 of the ESEA:

- Hold committee meetings, composed of parents and school staff, to review the Campus Improvement Plan.
  - Parents will be invited to participate in our annual campus survey to provide feedback on campus improvements. This feedback will be used to build our Campus Improvement Plan. Parents who show interest in providing feedback will be invited to participate in campus improvement plan meetings.
- Provide Title I, Part A school staff support in enhancing their School Campus Improvement Plans.
  - Training for school staff will be provided during our annual professional development days (August) as well as throughout the year via conferencing with teachers on the importance of parent involvement.
- Administer the Title I campus Parent Engagement Survey designed to identify the type of support, information, and resources that parents' need included in their Campus Improvement Plan and campus Parent Engagement Plan to better support their children's education and become more involved in their school.

3. Forest Hill Elementary will hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements and the right of parents to be involved in the Title I, Part A programs. The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite all parents of children participating in Title I, Part A programs to this meeting

and will encourage them to attend. These informative meetings may include, but are not limited to, the following:

- A meeting to inform parents about our Title I program will be held in the fall semester during our Open House event. Open House is scheduled for September 14, 2017. A second meeting will be held on the morning of September 15, 2017 to accommodate parents who were not able to attend the evening event the previous day.

4. Forest Hill Elementary will, in a timely manner, provide parents of participating children information about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet:

- Parents will be provided with student measurement tools and progress during student/teacher conferences which are held all year long. Parents will also be provided with progress reports every six weeks.

5. Forest Hill Elementary will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible. These may include, but are not limited to, the following:

- Parent conferences as needed, parent involvement meetings, and campus needs survey.

6. Forest Hill Elementary will provide each parent an individualized student report regarding the performance of their child on the state assessment in at least math, language arts and reading by:

- Receiving training on Skyward Family Access in the spring semester. This training will assist parents in learning how to access their child's scores. Parents will be reminded via School Messenger phone calls, Facebook, and Remind 101 text messages when the reports are accessible.

7. Forest Hill Elementary will provide assistance to parents of children served by the school, as appropriate, on important topics. These may include, but are not limited to, the following:

- Reviewing and understanding the state's academic content standards.
- Reviewing and understanding the state's student academic achievement standards.
- Reviewing and understanding the state and local academic assessments including alternative assessments.
- The requirements of Title I, Part A.
- How to monitor their child's academic progress.
- How to work with educators.
- Other topics that received strong parent interest as reflected by the Title I school Parent Engagement Survey.

8. Forest Hill Elementary will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parent engagement. These may include, but are not limited to, the following:

- Family Literacy Night.
- Nachos and Numbers: Family Math Carnival.
- Family Science Night at the Discovery Center.

- Skyward Parent Training.
- Monthly parent workshops on a variety of topics- immigration, safety in schools, how to become a volunteer, etc.

9. Forest Hill Elementary will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools. These efforts may include, but are not limited to, the following:

- Training for staff during professional development days.
- Ongoing training via handouts, videos, etc. on the importance of working with parents.

10. Forest Hill Elementary will, to the extent feasible and appropriate, coordinate and integrate TI parental engagement programs and activities with public preschool and other similar programs (e.g., Head Start, Parents as Teachers, etc.) that encourage and support parents in more fully participating in the education of their children. These efforts may include, but are not limited to, the following:

- Welcome Letter to 3 year old program at Nelson Street Head Start Program.
- Build relationships with parents at 3 year old program at Nelson Street Head Start Program.
- Provide resources to the Parents as Teachers Program and HOPES Program.
- Invite Parents as Teachers Program and Region 16 Early Head Start to night events.

11. Forest Hill Elementary will take the following actions to ensure that information related to the school, parent programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand. These may include, but are not limited to, the following:

- Letters sent in home language.
- Use of interpreter to communicate with parents and staff.
- Use of language device when interpreter is not available.

### **PART III. Discretionary Components of the Forest Hill Elementary Title I Parent Engagement Plan**

Forest Hill Elementary may provide discretionary activities that build parents' capacity for engagement in Title I schools and the school system to support their children's academic achievement; these may include, but are not limited to, the following:

- Involving parents in the development of training for teachers, principals, and other educators to improve the effectiveness of that training.
- Providing necessary literacy training for parents from Title I, Part A funds, if the school district has exhausted all other reasonably available sources of funding for that training.

- Establishing a campus Parent Engagement Advisory Council to provide advice on all matters related to parental engagement in Title I, Part A programs.
- Developing appropriate roles for community-based organizations and businesses, including faith-based organizations, in parental engagement activities.
- Providing other reasonable support for parental engagement activities under section 1118 as parents may request.

#### **PART IV. Adoption**

Forest Hill Elementary's Title I Parent Engagement Plan has been developed jointly with, and agreed upon with, parents of children participating in Title I, Part A programs, as evidenced by the minutes and sign-in sheet of our parent participants that helped review, modify and approve this plan.

This plan was adopted by Amarillo Independent School District on April 10, 2017 and will be in effect for the period of the 2017-18 academic year. The school will distribute this plan to all parents of participating Title I, Part A children on or before September 15, 2017 through the following avenues and in the following languages:

- Parents will be provided with Title 1 Parent Engagement Plan at our Back to School Night as well as during parent/teacher conference in the fall semester. The Plan will also be available on the school website all year long. Forest Hill Elementary will have the Parent Engagement Plan accessible to parents in the Parent Resource Center at the front of the school. The Title 1 Parent Engagement Plan will be available in English and Spanish.
